# RATES & POLICIES

## REGISTRATION

All parents must register their child in the before/after care program prior to the child attending the program. Fee: \$25.00 per family.

## WALK-INS

Walk-ins are accepted for both before and after care. Parents will be expected to fill out a registration form at drop off or pick up.

## FEES:

Fees for before and after care MUST be paid by Friday for the following week.

**Before Care:** \$5.00 pre-paid per child per day  
\$6.00 day of per child per day

**After School:** \$10.00 per child per day pre-paid  
\$12.00 per child day of

**Registration:** \$25.00 per family

## POLICIES:

- Mandatory sign-in for both before and after care—no drop offs.
- Must be pre-paid to get reduced price.
- After 2 days of account not being paid, students will not be allowed to return to before or after care.
- Please be advised that ASP closes at 6:00 p.m. If you anticipate any conflict with our schedule, you should consider other means of care for your child.
- Late fees accrue after 6:00 p.m. at a rate of \$1.00 per minute. After 3 late pick ups without notifying the director, the family will be suspended from the program. Authorities will be called for any child not picked up by 6:30pm without notifying the director.
- Overdue balances must be paid immediately. Neglected balances will result in suspension from the program.
- If a family has been suspended from the program and parents continue to leave children at school, authorities will be called.
- Please contact the school principal for any financial hardships.
- Participation in before and after care is a privilege. Students are expected to follow school rules and be respectful toward before and after care staff. Serious behavior infractions or repeated misbehavior may result in students being removed from the program. Students who are in In School Suspension (ETO) for an extended part of the day will not be allowed to attend ASP and should be picked up in the front office at 3:00pm.

## MISSION

## BEFORE SCHOOL CARE (BSC):

Hours: 6:30-7:25am

Students may be dropped off on the café side beginning at 6:30am.

Breakfast is included. Students will dismiss to their classrooms.

## AFTER SCHOOL PROGRAM (ASP):

Hours: 2:45-6:00pm

After care program meets in the rear of the building near the gym. Look for the sign on the sidewalk to indicate where children should be picked up.

- **K-2** grade children who regularly attend our program are placed in ASP at 2:45 when carpool begins. These children leave their classrooms and are routed directly to ASP.
- **3rd-8th** grade students are placed under our care at **3:00 p.m.**
- Any students not picked up at the end of regular carpool at 3:30, will be sent to ASP.

## .Homework

- There is a structured homework time for each after care class. Children should bring their homework to the after care program when they come. No child will be allowed to return to class after dismissal.
- Students should also have a book to read in their backpacks. Reading is part of every child's homework so he/she can use this twenty to thirty-minute period to do the required reading.
- Our staff will help with homework but parents should double-check to see that assignments are complete and correct.
